Dear Mr Toulmin,

I am writing to you on behalf of the All-Party Parliamentary Inquiry into Antisemitism to request a written submission for the purposes of our investigation.

The Inquiry has been launched in response to evidence that British Jews are living in a state of fear and discomfort as a result of a perceptible rise in antisemitism.

It is important that all relevant institutions and organisations provide us with their analyses in order that the Inquiry panel can be fully briefed on the situation and make responsible recommendations to Parliament. We will be investigating the nature of contemporary antisemitism, evaluating current efforts to confront it, and will consider further measures that can be usefully introduced.

Organisations and individuals wishing to make written submissions are invited to do so by 9<sup>th</sup> January 2006. Each submission should include the name and postal address of the individual or organisation and state whether it has been prepared specifically for the Inquiry. Where submitted by an organisation rather than an individual, the submission should briefly explain the nature and membership of the organisation. Oral evidence will be taken in Parliament, beginning in January 2006. A report is expected to be published in the spring.
